## LETTER OF INQUIRY

### I. Ordering Party

Hereby we invite you to submit a price offer for: snack machines - 4 pcs. - CPV code - 42215000 -6 - Machinery for the industrial preparation or production of food or drink

### II. Description of the subject of inquiry:

1. The subject of the order is purchase of snack machines - 4 pc, with the following parameters and characteristics:
  - matrix min. 6 wafers
  - wafer diameter min. 90 mm
  - capacity – min. 2000 pieces per hour
  - min. heating power - 12 kW
  - power supply 400 V.
  - mold opening min 200mm for easy cleaning
  - ability to quickly change the dose (max 1 min.)

### III. Terms of participation in the inquiry and the assessment description

- 1) Offer validity – min. 30 days - evaluation based on the information contained in the template of the offer
- 2) Due date for order completion: 31.03.2021 - evaluation based on the information contained in the template of the offer

### IV. Assessment criteria:

- 1) The maximum number of points - 100.
- 2) In the course of the examination and evaluation of the offer, the Ordering Party may demand from the bidders explanations regarding the content of the submitted offers.

The Ordering Party will consider the most favorable the offer, which shall not be rejected and will receive the highest number of points awarded within the criteria established under criteria 1 and 2.

Evaluation method:

1. The most advantageous offer in the price range (the lowest price) = 80 points
2. The most advantageous offer in the scope of the guarantee (the longest guarantee) = 20 points.
3. The sum of criterion 1 and criterion 2 will be the determining factor.

Criterion	Scoring	Evaluation method
Price	80%	The ratio of the lowest price to the price of the assessed offer, multiplied by 80
Guarantee	20%	The ratio of the guarantee of the assessed offer to the longest guarantee multiplied by 20

V. Term and method of offers submission:

- 5) In the course of the examination and evaluation of offers, the Ordering Party may demand clarification from the Bidders regarding the content of submitted offers.
- 6) The Ordering Party does not allow partial submissions.

VI. Bidding exclusions:

The order can not be granted to affiliated entities in person or in equity with the Employer. Person or capital-related entity means the reciprocal relationship between the beneficiary or the persons authorized to incur obligations on behalf of the



beneficiary, the activities connected with the preparation and conduct of the selection procedure for the contractor and the contractor, consisting in particular of:

- A. participating in the company as a partner in a civil law partnership or partnership,
- B. holding at least 10% of shares, unless the lower threshold results from legal provisions or has not been determined by the Managing Authority,
- C. acting as a member of a supervisory or management body, proxy, attorney
- D. marry, kinship or affinity in a straight line, second degree affinity or second degree affinity in the lateral line or in relation to adoption, care or guardianship.
